
# Middle Tennessee State University Office of Student Conduct July 1, 2023 – June 30, 2024


## Total Number of Disciplinary Cases: 183 Approximate Number of Consultations: 72


A **disciplinary case** is defined as a student or organization that has been charged with a disciplinary offense. The case number does not reflect the total number of disciplinary referrals made to the office. It also does not account for consultations. One student may have multiple cases, and one case may have multiple violations.


The following data presents a synopsis of the breakdown by gender and classification of the students who had discipline cases with the Office of Student Conduct during the specified time period.



The office consistently sees more males than females and more freshmen than any other classification. It is important to note that many disciplinary cases have multiple referral sources. For example, many housing incidents also involve the MTSU Police Department. The MTSU PD is counted as the referral source when accompanying reports from other sources exist.

The following chart presents the number of violation types the office adjudicated. The violation type total number reflects the total number of times this violation was assigned to a student. The total number does not reflect how many times the student was found in violation of that specific rule. *The total number of violation types will exceed the total number of disciplinary cases handled by the office.* One student may have multiple violation types within one disciplinary case. The percentage reflects the percentage of the total number of all violations.

The statistics contained in this report represent disciplinary cases adjudicated by the Office of Student Conduct for the time period indicated. Formal charges may have also been filed with the MTSU police department and/or the Department of Housing and Residential Life. It is possible that a single violation may appear in reports from all three departments. Disciplinary matters adjudicated solely by the Department of Housing and Residential Life are **not** reflected in these statistics.

#### **Noteworthy Observations**

The overall number of conduct cases charged during this review period remained static as compared to the previous year. The office conducted more follow-up meetings with students due to the steady total caseload number. Marijuana violations continue to be the most prevalent issue that the office handles; however, there was an uptick in alcohol violations.

A significant amount of time is spent in consultations with various campus partners about handling student behavior and addressing behaviors before they become problematic. These matters were not tracked through the current student conduct software. The staff tracked these interactions internally. Not all consultations were tracked. The total number of consultations recorded for the review period was sixty two.

The office also handled a small amount of care cases including distressed students and students who were dealing with specific life circumstances that were hindering their ability to be successful at MTSU. These matters were not tracked through the student conduct software. The staff tracked these interactions internally. Not all consultations were tracked. The total number of recorded care cases for the review period was ten.

The office has petitioned to include an official care component at MTSU for several years. The office was granted permission to develop a five-year plan to incorporate a University-wide care team into current engagement efforts. This plan included transitioning the Student Assistance Coordinating Committee to a true Behavioral Intervention Team. The hope is that the five-year plan can be expedited to align with national best practices.

### **Engagement Efforts**

Staff members participate in various campus events to boost visibility and develop relationships with constituents outside of the student conduct process. These efforts include participation in Welcome Back events, athletic events, student organization meetings and events, tabling, and hosting educational sessions for faculty, staff, and students.

#### **Educational Outreach**

Staff members provide training and educational outreach for Housing and Residential Life, the Office of Fraternity and Sorority Life, Athletics, University 1010 classes, and other areas as requested.
